Description:

I had previously filed a complaint against Dr. Lyn Mangiameli. It was a preemptive complaint to prevent her from filing a report absent my participation or without an empirically valid assessment. Unfortunately, a report was filed anyhow. Dr. Lyn Mangiameli affirms herself that no consent was given and that I had refused an assessment. She goes on to say that the issue informed consent was ambiguous because I was not present. It suffices to say that if I refused to participate that there could be no informed consent and that by refusing one could deduce that consent was not given. Dr. Mangiameli went on to make recommendations of incompetency that is "a result of a mental disorder or developmental disability." You cannot make such a determination without an assessment, whether "limited", or otherwise. Making such a determination is particularly egregious given that she knew that a determination would affect my standing to protect my kids. Furthermore, she said that she read my motion to establish paternity for my youngest. That means that Dr. Mangiameli saw the evidence that my youngest daughter is in the custody of a rapist. If she would have properly done an assessment, she would have also seen a police report dated Nov. 19, 2018 that had a statement that I was the father of said child. Dr. Mangiameli's conduct was reckless because it not only endangered my children, but me as well. She stated that my reports of being poisoned by my former attorney was "implausible". She had no standing to say this. There is an active police investigation in that matter. SHE acknowledged reading the court transcripts in which I also stated that two ER doctors believed that I was poisoned. Who is Dr. Mangiameli to say that I am "delusional" and override a medical doctor's opinion. Stating such opinions on that report would likely make the perpetrator of the aforementioned crime more confident to continue the assaults. Dr. Mangiameli behaved completely unethical. I hope that the board takes appropriate action against her. I have posted more information on this website. Please see it, I am submitting it as part of my complaint.
