The undersigned affiant, after being first duly sworn according to law, states that Amanda Lynn Wolfe, whose name is otherwise unknown to the affiant, committed the

offense of Assault (39-13-101), in the above county on or about the

07 day of August, 2019. Further, affiant makes oath that the essential facts constituting said offense,

the sources of affiant's information, and the reason why his/her information is believable concerning said facts are as follows:

On August 07, 2019, Amanda Wolfe an officer with the Westmoreland Police Department conducted a traffic stop.

During the course of the traffic stop, a male passenger (Marley Colburn) fled the stop on foot, at which point a foot

pursuit took place by Officer Wolfe and Officer Elizabeth Lehner. The male stopped during the foot pursuit, at which

point, Officer Lehner gave Colburn verbal commands to lay down on the ground with his hands out to which he

complied with. Officer Wolfe then came over to Colburn and began handcuffing Colburn while he was on the

ground. After Colburn was handcuffed, Officer Wolfe struck Colburn in the back multiple times while he was

handcuffed with closed hands. Your Affiant has conducted multiple interviews, as well as, reviewed body camera

footage regarding the traffic stop. While interviewing Marley Colburn, your Affiant also observed bruising to

Colburn's upper back. Based upon the evidence located during the investigation, probable cause exists to charge

Wolfe with assault (misdemeanor).

WESTMORELAND POLICE OFFICER FACES ASSAULT CHARGE

SUMNER COUNTY – An investigation by Special Agents with the Tennessee Bureau of Investigation has resulted in the arrest of a Westmoreland Police Officer on an assault charge.

At the request of 18th District Attorney General Ray Whitley, on August 9th, TBI Agents began investigating an allegation of excessive use of force against Westmoreland Police Officer Amanda Wolfe. During the course of the investigation, Agents learned that on August 7th, during a traffic stop, a passenger who had active warrants exited that vehicle and fled on foot. After a brief chase, the man was ultimately apprehended and handcuffed. The investigation determined that while the individual was handcuffed and compliant, Officer Wolfe repeatedly struck him in the back.

On Tuesday, Amanda Lynn Wolfe (DOB 04/23/1993) turned herself in to authorities, and was charged with one count of Assault. She was arrested and booked into the Sumner County Jail, and was released on her own recognizance.
