- 6. I was assigned to USP Special Housing number 4 Officer on July 29, 2015 from the hours of 6:15 a.m. to 2:15 p.m. >
- 7. Yes, I do recall the events that took place on July 29, 2015. I observed inmate Cyrus Sullivan #74918-085 being aggressive and refusing to go back into his cell after his cell was searched. Inmate Sullivan then became combative while Officer

Luna attempted to put him back into his cell. Inmate Sullivan turned in an aggressive manner and struck Officer Luna in the facial area. I assisted in placing Inmate Sullivan on the ground in order to gain control of his aggressive behavior. I assisted staff in controlling inmate Sullivan's I did hear a staff member say something about him coming out of restraints but I don't remember who it was. Once we get full control of Inmate Sullivan he was then escorted to the observation cell to be medically assessed. \*\*

- 8. At no time did I see Officer Luna twist inmate Sullivan's wrist nor did I see Officer Luna punch inmate Sullivan while he was on the ground. ⋞
- 9. At no time did I see Lieutenant Williams punch inmate Sullivan in the face while we were in the observation cell.
- 11. I have read this affidavit thoroughly and I have been given the opportunity to make change, corrections and additions.
- 12. I have no further information I can provide relative to this investigation at this time.
- 13. I have fully cooperated with this investigation and I do not know of, or have any additional information that I have not already mentioned concerning this case. I understand I am not to discuss anything about this interview or any other information concerning this case, with anyone other than a Special Investigative Supervisor/Agent (SIS/SIA).
