## Summary:

On 04/25/2018 at approximately 0700 hours, Inmate Sullivan, Cyrus refused to go to court, threatened staff members and disrespected staff members.

## Action Taken:

On 04/25/2018 at approximately 0700 hours, Sergeant Neifert attempted to get Inmate Sullivan chained up for court but Inmate Sullivan refused. I tried to talk to Inmate Sullivan afterwards and let him know that if he refused to go to court he would be written up.

Inmate Sullivan then said "Do you want your address published along with your other colleagues?". I told Inmate Sullivan that he just threatened staff and would be written up for that also. I offered Inmate Sullivan one more chance to go to court without the write up and he said "Punk ass Bobby Hill piece of shit mother fucker". I notified Inmate Sullivan that he would also be written up for disrespecting staff.

## Action Recommended:

I recommend that Inmate Sullivan be placed on Closed Custody classification due to his threats on staff members.
