A SHRET DISTANCE FROM THE SMEWALK OF ALSER, BOTH OF THOSE SIDEWALKS ARE VERY BUSY WHA PEDESTRUANK, EVEN AT THIS TIME OF YEAR, OFC. (LEMSER AND I FOUND MIMEROUS PLASTIC POP BOTTLES THAT APPEARED TO HAVE BEEN BLOWN UP, AND POP BOTTLE CARS WITH YAURS IN THEM.
