COMPUTER MONITORING PROGRAM PARTICIPANT AGREEMENT

General Provisions

1.	I,1	have been placed in the Computer Monitoring Program.
	I agree to comply with all program rules set	forth in this agreement, and with the instructions of my
	probation officer. I understand that this agree	ement stems from a specific condition of supervision
	that was imposed by the Court. I further under	erstand that failure to comply with its provisions or the
	instructions of my probation officer will be	considered a violation of my supervision which may
	result in action by the Court.	

- 2. I understand that I am required to provide my probation officer with truthful and complete information about my entire computer system, including all computer hardware, software, and electronic services and storage devices to which I have access, as directed on the Computer/Internet Data Form. I further understand that I must receive prior approval from my probation officer before engaging in any action which may result in changes, additions, or deletions to the information I have provided.
- 3. I will disclose all online accounts, including user-names and passwords, to my probation officer upon request. I will also provide telephone/Internet service provider billing records on a monthly basis, as well as proof of the disconnection or termination of such services if required by my probation officer or the Court.
- 4. I will not subscribe to or obtain services from any Internet Service Providers or other online service providers other than those approved by my probation officer.
- 5. I understand that I am prohibited from using or possessing any computer(s) or computer equipment other than those authorized by my probation officer. This includes, but is not limited to, computers at my place of employment, private homes, libraries, schools, or other public locations.
- 6. I understand that I am prohibited from having another individual access the Internet or other online services on my behalf.
- 7. If directed by the probation office, I agree to allow the probation office to install software designed to monitor computer activities on any computer I am authorized to use. I understand that the software may record any and all activity on my computer, including the capture of keystrokes, application information, Internet use history, email correspondence, and chat conversations. I will not to attempt to remove, tamper with, or in any way circumvent the software. I agree to immediately report any problems with the monitoring software to the probation officer.
- 8. I will not attempt to alter, delete, or modify any system files in an attempt to circumvent the monitoring of my computer usage. I understand that the probation office will perform periodic inspections of these files to ensure compliance. I further understand that I am solely responsible for the content, programs, and data that may be stored on the computer.
- 9. I will notify all individuals that use or have access to my computer system that it is subject to monitoring and/or search/seizure.
- 10. I will not use or possess any software program or device designed to hide, alter or permanently erase computer files, including records/logs of my computer use or Internet activities. This includes the use of encryption, steganography, and cache/cookie removal software.

- 11. I will not install new hardware, software, or effect repairs on my computer system without receiving prior permission from my probation officer.
- 12. I understand that my probation officer may use measures to assist in monitoring my compliance with these conditions, such as using tamper resistant tape to cover unused ports and seal my computer case, and conducting periodic hardware/software audits of my computer(s).
- 13. I understand that my probation officer will use telephone calls and unannounced personal visits to monitor my compliance. When I am at home, I agree to promptly answer my telephone or door.
- 14. I will not access any social network website, including but not limited to Facebook and Myspace, and I will not create or maintain a profile on any social network website.
- 15. I will not access any dating website or service and I will not create or maintain a profile with any dating website or service.
- 16. I will not utilize any software, or visit any web sites, that allows me to, nor will I engage in any, online chat; online Instant Messaging, mobile network text (SMS) messaging, or any other electronic form of direct text messaging (other than email).
- 17. I will not utilize any software or visit any web sites that allow me to, nor will I engage in any, video conferencing, video chat, video calling, video telephony, or other forms of electronic communication that allow transmission of live video from one person to another.
