Keondra Kenetha Snow, 26, was charged with Sexual Misconduct with an Inmate.

Snow was booked at the Williamsburg County Detention Center.

The case will be prosecuted by the 3<sup>rd</sup> Circuit Solicitor's Office.

Williams was an inmate confined in the Detention Center, under the supervision of Snow. Snow admitted to the act of sexual intercourse with Williams, while on duty. This violation taking place at Williamsburg County Detention Center, in Williamsburg County, South Carolina. Sexual Misconduct with an Inmate is in violation of South Carolina Code of Laws, section 44-23-1150 as amended.
