ON SATURDAY, FEBRUARY 12, 2011, AT APPROXIMATELY 3:20 AM, I OFFICER KEITH ALBERT WITH THE IMPD WAS ON DUTY. WHILE DOING CROWD CONTROL AT THE INTERSECTION OF MERIDIAN STREET AND JACKSON STREET ON A HOMICIDE SCENE (CAD I110430381), MYSELF AND OFFICER DWAYNE MAY (F573) WERE APPROACHED BY A BLACK MALE, LATER IDENTIFIED AS LEGEDU NAANEE (B/M 9/16/1983) BY HIS CALIFORNIA DRIVER'S LICENSE. MR. NAANEE ATTEMPTED TO WALK NORTH INTO AN ACTIVE CRIME SCENE WHICH WAS TAPED OFF WITH YELLOW POLICE LINE TAPE. MR. NAANEE WAS STOPPED BY OFFICER MAY. OFFICER MAY INSTRUCTED MR. NAANEE HE WOULD HAVE TO TURN AROUND AND GO ANOTHER DIRECTION, DUE TO THE ACTIVE CRIME SCENE. MR. NAANEE REFUSED AND BEGAN ASKING OFFICER MAY, "WHY ARE YOU BEING AN ASSHOLE". OFFICER MAY CONTINUED TO REMAIN CALM AND ASKED MR. NAANEE TO WALK THE OTHER WAY SEVERAL MORE TIMES. MR. NAANEE CONTINUED SAYING "WHY ARE YOU BEING AN ASSHOLE". AS MR. NAANEE WAS SPEAKING, I COULD SMELL A STRONG ODOR OF AN ALCOHOLIC BEVERAGE, ON OR ABOUT HIS BREATH AND PERSON. HIS EYES WERE ALSO BLOODSHOT AND GLASSY. AFTER SEVERAL ATTEMPTS TO HAVE MR. NAANEE WALK A DIFFERENT DIRECTION AWAY FROM THE CRIME SCENE, HE REFUSED. I INSTRUCTED HIM HE WAS UNDER ARREST. I ATTEMPTED TO GRAB HIS LEFT WRIST TO PLACE HIM IN HANDCUFFS AND HE BEGAN TO ACTIVELY PULL AWAY FROM. MR. NAANEE CONTINUED TO PULL AWAY FROM ME AND BRACED HIMSELF UP AGAINST A METAL RAILING ON THE CLADDAGH IRISH PUB. AFTER SEVERAL ATTEMPTS TO GAIN CONTROL OF HIM, I DELIVERED ONE 2 SECOND BURST OF PEPPER SPRAY TO HIS FACE. AFTER BEING SPRAYED MR. NAANEE CONTINUED TO RESIST BY ACTIVELY PULLING AWAY AND TUCKING HIS HANDS, SO WE COULD NOT GET CONTROL OF HIM. MR. NAANEE WAS THEN PLACED ON THE GROUND AND CONTINUED TO RESIST ARREST BY PULLING HIS HANDS UNDER HIS BODY. I CONTINUOUSLY TOLD MR. NAANEE TO STOP RESISTING AND DELIVERED TWO KNEE STRIKES TO HIS RIGHT SIDE. MR. NAANEE RELEASED HIS ARMS AND WAS FURTHER PLACED IN HANDCUFFS. I INSTRUCTED HIM HE WAS UNDER ARREST FOR PUBLIC INTOXICATION AND RESISTING ARREST. I WALKED HIM OVER TO THE MEDICS (WISHARD MEDIC 18) LOCATED AT THE INTERSECTION OF MERIDIAN STREET AND JACKSON STREET. THE MEDICS WIPED OFF HIS MR. NAANEE'S FACE WITH A TOWEL. AS I WAS WALKING MR. NAANEE TO MY PATROL VEHICLE, HE MADE THE STATEMENT "DO YOU KNOW WHO I AM". MR. NAANEE THEN STATED, "I AM AN NFL PLAYER AND I AM GOING TO SUE YOUR ASS". AS I WAS FILLING OUT MY PAPERWORK, AN UNIDENTIFIED MALE, WHO STATED HE WAS MR. NAANEE'S FRIEND, APPROACHED ME TO SEE WHAT HAD HAPPENED. I EXPLAINED THE SITUATION TO HIM AND THEN TWO MORE UNIDENTIFIED PEOPLE

APPROACHED ME WHO WERE BELIEVED TO BE HIS AGENT. I ATTEMPTED TO EXPLAIN THE SITUATION TO THEM AND THEY REQUESTED I LET HIM GO. I EXPLAINED I COULD NOT DO THAT AND ONE GENTLEMAN TOLD ME I WAS GOING TO RUIN HIS CAREER. SERGEANT BARKER (F314) RESPONDED TO SCENE AND BEGAN TO SPEAK WITH THEM. MR. NAANEE WAS FURTHER TRANSPORTED TO THE MARION COUNTY APC, BY MCSD WAGON, DEPUTY M. PIERSON (P8543). ALL ABOVE EVENTS OCCURRED IN MARION COUNTY, INDIANAPOLIS INDIANA.
