

Summary:

On 6/9/18 at approximately 0900 hours I was working as a uniformed corrections deputy for the Columbia County Jail. Inmate Sullivan, Cyrus had submitted and misused an inmate medical request form, threatening a staff member

Narrative:

On 6/9/18 at approximately 0900 hours I was working as a uniformed corrections deputy for the Columbia County Jail. Nurse Nicole informed me that Inmate Sullivan, Cyrus submitted an inmate medical request form threatening medical staff. I was able to obtain a copy of the request form. The name the form was submitted by reads "Cyrus Sullivan". Date of birth as "6/26/83", Cell "BL2", and booking number "90740", dated for "6/8/18". All the information written on the inmate medical request form is consistent with Inmate Sullivan's information.

On the inmate medical request form Inmate Sullivan writes "Nancy Ronan- Fix my filling or I will forever damage your professional reputation, If you dont want your career to suffer long term do what I say from now on."

Inmate Sullivan is being written up for major rule violation 209 threatening a staff member.

Inmate Sullivan has received 3 or more misconduct reports within 30 days.

Inmate Sullivan is being written up for major rule violation 200 Habitual misconduct.

Inmate medical request forms are to be submitted to notify medical staff of any medical issues so the issues can be addressed. Inmate Sullivan used the inmate medical request form to threaten a staff member.

Inmate Sullivan is being written up for minor rule violation 107 inappropriate remarks or misuse of the inmate request form.

No privileged items were taken at the time off this incident as Inmate Sullivan is currently serving time on disciplinary segregation.

Inmate Sullivan was served the incident report, notice of rights and violations made against him.

Evidence:

Inmate medical request form attached to this report.

Recommendation:

Disciplinary segregation pending adjudication.

Remain closed custody classification.

## SIGNATURE

IN THE CASE OF A FORMAL HEARING INVOLVING AN INMATE CHARGED WITH A VIOLATION OF RULES IN THE COLUMBIA COUNTY JAIL, THE FOLLOWING ACTIONS MAY BE TAKEN BY THE INMATE. THE INMATE MAY PRESENT HIS OR HER CASE. THE HEARING OFFICERS SHALL BEAR TESTIMONY TO THE DEGREE NECESSARY TO DETERMINE WHAT THE FACTS ARE AND WHAT ACTION IS TO BE TAKEN. THE INMATE MAY REQUEST THE HEARINGS OFFICER CALL UP TO THREE(3) WITNESSES TO TESTIFY IN PERSON OR BY WRITTEN STATEMENTS.

INMATE SHALL BE PROTECTED AGAINST SELF INCRIMINATION AT DISCIPLINARY HEARINGS UNLESS THE HEARING ENTITY: A. WARNS THE INMATE THAT THE TESTIMONY CAN OR MAY BE USED IN A CRIMINAL PROSECUTION. B. ADVISE THE INMATE THAT IF HE OR SHE REFUSES TO ANSWER QUESTIONS ASKED DURING THE HEARING THE DEPUTY CAN MAKE AN ADVERSE INFERENCE FROM HIS SILENCE. THE HEARINGS OFFICER MAY DENY WITNESSES IF THEIR TESTIMONY WOULD BE CUMULATIVE, REDUNDANT OR IRRELEVANT.
